Delegated services include prior authorization requests for Medicare Advantage individual and group retiree members in the states of **California, Colorado, Connecticut, Georgia, Indiana, Kentucky, Maine, Missouri, New Hampshire, New Jersey, New Mexico, Nevada, New York, Ohio, Tennessee, Texas, Virginia, Washington, and Wisconsin**

For services beginning on or after July 1, 2023, prior authorization requests for Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) services will be reviewed by Carelon for place of service 12 (home), 13 (assisted living facility), and 14 (group home). The goal of this program is to ensure members receive the right product for the right duration of time in the home.
